

LRDL was founded by its chairman Robert Poots in January 2002 to source, model and administer funding to assist the strategic sustainability of Farmers and the Rural Community in the Lisburn City area. It was successfully expanded to facilitate Antrim, Newtownabbey, Carrickfergus, Craigavon, and Armagh council rural areas in Northern Ireland. LRDL successfully won and administered funding and training to the rural population fast tracking them to enable training for computer literacy and business administration in the fast-moving EU market place. On completion of its objective LRDL entered its exit strategy and became an historic records data base as required under European Funding regulations until 2014 which saw the completion of this phase and the closing of the company. The extensive success of the company identified by the local government was demonstrated through the rolling out across all council areas in Northern Ireland of "local Action groups" modelled on the LRDL structure to administer future EU Leader funding

Key achievements include:

- Successfully negotiated with Lisburn City Council [LCC] to mandate LRDL to manage the rural area of Lisburn.
- Successfully negotiated with Lisburn City Council to financially support LRDL for 5 years through investing £250,000 core funding for the period.

Established in 1938, Dromore Primary School is the local primary school for the education of children from 4 to 11 years of age and comprising 600 pupils, 33 teaching staff and 50 ancillary staff. The Governors are ultimately responsible for the overall management of the school which has an annual budget of £1,800,000 and a school fund account of £7,625,000. A new school has been in development since 2000 and has been politically agreed, site purchased, planning passed, modelled, on site under construction in 2015 and opened in September 2016 with a student increase to 700 pupils. The new buildings were officially opened by Her Royal Highness the Duchess of Cornwall on 11 May 2017.

At scripting this document, the UFU has over **11,500 members** who are supported by 25 regional offices and the headquarters building in Belfast.

How the Organisation works: - the UFU grass roots members discuss policy issues at their 25 local Group meetings which are examined at the 6 County meetings. These are then examined in detail at the Unions Central Committees, before policies are ratified at the UFU's monthly Executive Committee meeting. Executive management decisions are taken by the UFU council.

Lisburn Strategy Partnership [lisburn Peace and Reconciliation Partnership] was one of 32 Strategic Boards established in Northern Ireland as a cross community, cross sectorial board to deliver distinctive European Union Structural Funds Programmes aimed at reinforcing progress towards a peaceful and stable society and to aid peace and reconciliation and participated fully in:-

- Peace I initiative- EU Special Support Programme for Peace & Reconciliation (1995-1999) ...total initiative funding €500 million [+ €167million national contribution]
- The Belfast/Good Friday agreement [April 1998].
- Peace ii initiative- EU Programme for Peace and Reconciliation in Northern Ireland and the Border Region of Ireland [2000-2004]
 - ...total initiative funding €531 million [+€304million national contribution]
- Peace ii initiative- Extension EU Programme for Peace and Reconciliation in Northern Ireland and the Border Region of Ireland [2005-2006]
 - ...total initiative funding €78 million [+€82million national contribution]
- Peace iii initiative- EU Programme for Peace and Reconciliation in Northern Ireland and the Border Region of Ireland. [2007 – 2013]... total initiative funding €225 million[+€108million national contribution]

Comet Shadow Partnership (**Co**uncils of the **Met**ropolitan Area) was established in 2002 as a vehicle for collaboration on a range of policy, social, economic, and environmental issues between the six local authorities within the Greater Metropolitan area of Northern Ireland, namely Belfast, Carrickfergus, Castlereagh, Lisburn, Newtownabbey and North Down who all previously failed to secure Interreg recognition and funding.

The COMET region covers an area of approximately 960 sq. kms, a population of 646,550 (according to the 2001 census), 38% of Northern Ireland's total population. Primarily the focus for collaboration to date has been in respect to local and regional economic development opportunities funded through European Interreg iiiA and ivA competitively bid programmes. The current phase of the programme, which runs from 2007-2014, is called the INTERREG IVA Programme. This covers Northern Ireland, the border region of Northern Ireland and the Republic of Ireland and western Scotland. It has a total competitively accessed regional budget of €258 million with its objective to support strategic cross-border co-operation for a more prosperous and sustainable region. The Shadow Partnership successfully lobbied and won recognition as the areas representative Interreg board and gained full access to the Northern Ireland regional funding on 05 April 2005.
